



## INTRODUCTION

I, Ricardo Beas, a complainant in the instant matter, declare that the following is true and correct to the best of my knowledge, beliefs and upon information. I further declare that the named persons, individuals, institutions, fictitious entities and governmental agencies named in my above referenced Vaccine Class Action Complaint (DOJ I.D.# DJ 144-11-0, and HHS Transaction Number 17-277069, hereinafter my "Complaint") and those persons named in this Amendment One, all hereinafter referred to as "Criminal Participants," are acting in collusion with each other to impose a nationwide mandatory vaccine government sponsored program, contrary to my health and against my inalienable God-given, Natural, Common Law, California State and U.S. Constitutional, and International rights, as well as such health and rights of HUNDREDS OF MILLIONS of other residents and citizens of this country. **U.S. HOUSE RESOLUTION 327 (H.R. 327)  
AN ATTEMPT TO FRADULENTLY DENY THE LINK BETWEEN  
VACCINES AND SERIOUS AND DEADLY INJURY**

As it has been clearly proven by all the evidence, findings of fact and conclusions of law provided in my  
Vaccine Class Action Complaint and all my other filings and correspondence with the DOJ and HHS  
related to my Complaint, the named Criminal Participants are working together to pass state and federal  
legislation intended to make CDC recommended vaccines for children and adults mandatory and

compulsory through coercion upon the U.S. population in order to go to school, work, travel, receive government benefits, and immigrate, etc.

H.R. 327 is an attempt by the Vaccine Manufacturers through their lobbyist and criminal cohorts, together with the herein named House of Representatives Criminal Participants to pass legislation that will directly or indirectly make it impossible to challenge the “all vaccines are safe” false narrative promoted by the pro-vaccine and pro-forced-vaccine Criminal Participants in any state or federal court. This proposed legislation was sponsored by Representative Adam Schiff (D-CA-28), and it is titled:

***“H.Res.327 - Recognizing the importance of vaccinations and immunizations in the United States”***

The bill’s Summary reads as follows:

*“Commends the international community, health organizations, the private sector, school and community leaders, and faith-based organizations for bolstering health through vaccination.*

***Recognizes that the lack of vaccination can cause a public health crisis and that there is no credible evidence that vaccines cause life-threatening or disabling diseases in healthy children or adults.***

*Encourages a continued commitment to research to **improve vaccines and develop new vaccines.***

***Urges parents to follow the scientific evidence and consensus*** of medical experts in favor of *timely vaccinations to protect their children and their community.*”

The intent of H.R. 327 is to legally declare and imply through federal legislation that there are no credible or reputable studies or actual evidence (like thousands of real life stories of persons being seriously and severely affected by vaccines shortly after receiving them)<sup>3</sup> that proves that vaccines can be harmful to an individual in any way, shape or form. Such a statement is false and fraudulent, and criminal when known and denied, as proven by the overwhelming evidence provided in my Complaint.

The term “Urges” as used in H.R. 327 will become a mandatory order for children and adults to vaccinate and be in CDC compliance, once any court is presented with a vaccine injury or other anti-mandatory-vaccine lawsuit, as the Courts will point at H.R. 327’s text, will declare it an Act of Congress that is Constitutional, and will claim that the statements presented therein are irrefutable settled science as regard vaccine safety, excluding any evidence to the contrary from being introduced or considered.

**INVOLVED U.S. REPRESENTATIVES ARE BRAINWASHED, BRIBED, COERCED AND/OR BLACKMAILED

Through brainwashing, bribery,<sup>4</sup> coercion, and or blackmail the Vaccine Manufacturers and their lobbyist et al have infiltrated the offices of each one of the Criminal Participants named in this Amendment One, probably even preparing and providing the text of H.R. 327 for Representative Schiff to Sponsor and promote, just as they have done with other state's legislation, such as California's AB 2109 and SB 277.

As relates to hiding the true dangers of vaccines, through their bribery of and infiltration into government agencies, such as the CDC and the FDA, Merck and other vaccine manufacturers et al have gained approval to sell their vaccines regardless of the risks known by the vaccine manufacturers and cited in their vaccine inserts, have encouraged or forced such agencies to heavily promote mandatory vaccination for children and adults, and had the CDC manipulate vaccine studies' data to eliminate any evidence of vaccine injury, in particular Autism.<sup>5</sup>

**THE INVOLVED U.S. REPRESENTATIVE ARE

To become a U.S. Representative in Congress, each one of the newly named Criminal Participants signed an Oath of Office to support and defend the United States Constitution, which **requires each one of them to protect and not interfere with my inalienable God-given, Natural, Common Law, U.S. Constitutional, international, health-conscience, and religious/faith-based rights, like those of others, not to vaccinate myself, my children and anyone under my care because of vaccines' proven potential and in often cases actual minor and serious harm to those vaccinated, as proven in my Complaint.**

Therefore, each U.S. Congressmen is contractually obligated to protect my rights and help me secure my life, which includes my good health; my freedom, in particular freedom from vaccine-related diseases and the resulting pain and suffering; and my property, which finances depend on my good health; as well as that of all persons in the land mass known as the United States of America; to defend us against any corrupt corporations or other fictitious entities and those who own and control such entities, such as the owners of such enterprises, in particular the major stock owners and their Board of Directors.

By promoting H.R. 327 each one of the name Congressmen and their Staff, who also took an Oath of Office to defend the U.S. Constitution, are in violation of their Oath of Office, are acting in a criminal manner, are conspiring with others to deny the harm of vaccines and are promoting a mandatory-

vaccine government-sponsored agenda affecting the health of millions, and consequently because of such actions lose all their “Government Immunity Clause” protection for failure to perform the required actions based on the responsibilities of their employment and position to protect our rights under the U.S. Constitution.<sup>6</sup>

<sup>6</sup> The general rule at common law was that in order for a government official to be protected by absolute immunity for common law torts, not only did the official have to be acting within the outer perimeter of his/her official duties, but the conduct at issue also had to be discretionary in nature. .... However, the immunity conferred by FELRTCA does not extend or apply to suits against federal employees for VIOLATION OF THE CONSTITUTION OR FEDERAL STATUTES. Thus, government officials sued for constitutional torts continue to be protected only by qualified immunity. See also Scheuer v. Rhodes, 416 U.S. 232, 94 S.Ct. 683, 1687 (1974); Ex parte Young, 209 U. S. 123 (1908).

<sup>7</sup> Title 18 USC Section 241, Conspiracy Against Rights, states in part the following: “If two or more persons conspire to injure, oppress, threaten, or intimidate any person in any State, Territory, Commonwealth, Possession, or District in the free exercise or enjoyment of any right or privilege secured to him by the Constitution or laws of the United States, or because of his having so exercised the same... — They shall be fined under this title or imprisoned not more than ten years, or both; and if death results from the acts committed in violation of this section ... they shall be fined under this title or **imprisoned for any term of years or for life, or both, or may be sentenced to death.**”
