I was created by almighty God in His image (Genesis 1:27), as was created the land in which I was born and where I presently live in (Genesis 1:1), according to the Holy Bible,⁵ the land that our Lord gave us to be fruitful and multiply in (Genesis 1:28).

I am Child of God, like all men and women on planet Earth, protected by Jesus Christ Himself and God,⁶ as those described by Jesus when he said, in Matthew 19:14, *“But Jesus said, Suffer little children, and forbid them not to come vnto me: for of such is þe kingdome of heauen.”*⁷

I am the “sheep,” as are all in the genealogy of Adam, “my sheep in general,” referred by, but not necessarily under the control or jurisdiction of,⁸ Pope Boniface VIII in his **Unam Sanctam** Bull promulgated on November 18, 1302.

In the **Unam Sanctum** Pope Boniface VIII claims⁹ the following:

1. The Catholic Church has spiritual and temporal power over what we call planet Earth.
2. The power of the Church over the material world is to be administered BY the Church.
3. That Kings and soldiers who are allowed to be second-level administrators of the temporal, material, earthly realm, are UNDER THE AUTHORITY OF THE CHURCH, ***“the temporal authority, subjected to spiritual power.”***
4. *“Spiritual power surpasses in dignity and in nobility any temporal power whatever, as spiritual things surpass the temporal.”*
5. *“It belongs to spiritual power (the Church) to establish the terrestrial power and to pass judgment if it has not been good.”*
6. The authority of the Church is not human, but rather divine, and whoever resists this power thus ordained by God, resists the ordinance of God (Rom 13:2).

According to the Church, based on **Unam Sanctum** and other edicts of Canon Law, the Church has the spiritual and temporal/material power over all governments, de jure and de facto on planet earth, including power over all artificial and fictitious entities created and condoned by the Church, in the form of local, state, federal, national and international governments and organizations,¹⁰ which in turn

authorized and issued written or implied contracts, trusts, estates, grants, charters, constitutions, writings, corporations, agencies, administrations, departments, agreements, ad infinitum, established in and operating on land and sea pretending to be lawful governments and which are ultimately chartered and allowed to exist by the Church – the Church having the authority and obligation to disband/dissolve them for breach of contract if such entities act against mankind contrary to God’s wishes and the Church’s claimed unquestionable obedience to God.

THUS AND THEREFORE, the Church claims that it has Spiritual, Sea and Land jurisdiction over planet Earth’s corporative fictitious entities – AND HAS DIVINE AND OBLIGATED LEGAL JURISDICTION OVER THIS MATTER TO PROTECT ME AND ALL INHABITANTS ON EARTH IF IT IS TO FOLLOW AND COMPLY WITH WHAT THE CHURCH CLAIMS IS GOD’S LAWS, ORDINANCES AND MANDATES AS NOTED ABOVE.

POPE FRANCIS, CLAIMED BY THE CHURCH TO BE THE VICAR OF CHRIST ON EARTH, HAS A GOD ORDAINED, OR AT LEAST A CONTRACTUALLY COMMITTED OBLIGATION TO INTERVENE IN THIS MATTER AND MUST IMMEDIATELY ACT UPON MY/OUR REQUEST, TAKING SWIFT ACTION AGAINST THE PERPETRATORS OF THE CRIMES TO ALL MEN AND WOMEN THAT WILL BE NOTED BELOW – LESS POPE FRANCIS AND THE CHURCH RESIST THE ORDINANCE OF GOD, WHICH ACTION AND INACTION WOULD PROVE THAT THE CHURCH DOES NOT REPRESENT EITHER JESUS OR GOD AS CLAIMED, AND IS THEREFORE A FRAUD, ANOTHER PREDATOR UPON THE PEOPLE, AN ABOMINATION UPON THE EYES OF GOD, AND SUBJECT TO LAWSUITS BY ALL MEN AND WOMEN THAT HAVE SUFFERED BY SUCH POSSIBLE FRAUD AND CRIMINAL ACTIVITY.¹¹

CRIMINAL COMPLAINT:

In the land mass known as the Continental United States of America, operates a de facto government (sic, commercial corporations), under the guise of law, under multiple names, including but not limited to: the united States of America, the United States of America, the UNITED STATES OF AMERICAN, the UNITED STATES, etc., who are involved in multiple activities worldwide intended to steal the wealth, damage the good health, and destroy the spiritual wellbeing of billions of men and women around the world, with the purpose of world-wide domination and their own self-enrichment, with complete disregard to our dignity, the environment and all creations of God. And to make matters worse, those who have profited most from this gigantic fraud scheme have proposed to kill the majority of men and women -- their creditors -- and in this way escape their obligation to repay the property, interest, and collateral the people are owed and has otherwise been stolen from them.¹²

This de facto American and related worldwide governments and controlling organizations are eloquently explained by Professor Emeritus Avram Noam Chomsky, when he noted in one of his speeches that the London publication “Financial Times” called this evil organization “the De Facto

World Government,” noting that this organization operates in secret, that they determine the basic things that happen in life, that is has its own institutions such as the IMF, the World Bank, the World Trade Organization, as well as the executive branches of the seven rich countries, and that all the major institutions of the world are under their totalitarian control.¹³

This was also confirmed by President Bill Clinton, when he responded to a question by reporter Sarah McClendon regarding UFO disclosure and he said, **“Sarah, there’s a government inside the government, AND I DON’T CONTROL IT.”**

According to the book, “You Know Something is Wrong When ... An American Affidavit of Probable Cause,” by Anna Maria Riezinger & James Clinton Belcher, circa 2014-2015, page 149, in 2009 a delegation of Americans (people residing in the continental United States) had an audience with Pope Benedict XVI, where all of the above illegality was exposed and where actions were requested regarding the misadministration of the Church’s Global Estate by the United States’ (sic, as noted above) de facto “federal government” and noted that the individual public trusts were violated and plundered. The authors, if different from the delegation noted above, additionally filed their own Affidavit of Probable cause with the Pope/the Church, duplicated in their book, pages 222-264.

According to this book, Pope Francis acted upon this complaint and demand for action, by way of Pope Francis’ Motu Proprio Apostolic letter of July 11, 2013.

In his Motu Proprio letter Pope Francis notes that:

1. The competent Judicial Authorities of Vatican City State shall exercise **penal** jurisdiction over (a) crimes committed against the security, the **fundamental interests** or the patrimony of the Holy See (the Unum Sanctum or other actual or implied Global Estate).
2. This authority extends to “public officials and personnel of the various organs of the Roman Curia **and of the Institutions (corporations, trusts) connected with it**, including,

*“(c) Those persons who serve as representative, managers or directors, as well as persons **WHO EVEN DE FACTO manage or exercise control over the entities directly dependent on the Holy See,**” which according to the **Unam Sanctum** bull, include all existing legal/de jure or de facto corporate/business entities on earth, whose authority have root on the Church’s authority.*

In his speech before the United States Government (sic) of September 24, 2015 Pope Francis told the de jure and/or the de facto governing power the following:

*“Yours is a work which makes me reflect in two ways on the figure of Moses. On the one hand, the patriarch and lawgiver of the people of Israel symbolizes the need of peoples to keep alive their sense of unity by means of just legislation. On the other, the figure of Moses leads us directly to God and thus to the **transcendent dignity of the human being**. Moses provides us with a good synthesis of your work: **you are asked to protect, by means of the law, the image and likeness fashioned by God on every human face.**”*

The orders of the Church, as stated above, have been violated, as is clearly address by Pope Francis' Motu Proprio letter regarding de jure and **de facto** persons, institutions and governments. These persons and institutions have miss-managed the Church's Global Trust Estate,¹⁴ have exercised illegal sea/admiralty jurisdiction over the land jurisdiction of the land mass known as the Continental United States, in violation of the actual powers assigned to each jurisdiction. The Church must recognize and protect God's children, acknowledging that all men and women:

1. Have Natural and Unalienable Rights that come from God, not from any sort of corporate or other chartered artificial/fictitious commercial entity.
2. Have beneficial interest in the land mass known as Planet Earth and its resources.
3. Are protected by national trust indentures, international treaties and commercial agreements, and by orders given by God as proclaimed by the Unam Sanctum Bull.
4. In the Continental United States, have a right to due process of law and to Common Law Courts as noted in the Northwest Ordinance of 1787, as well as the various united States Constitutions, Amendment VII. My rights are also described in the Treaty of Peace, Paris, 1783.
5. The Church must recognize and publicly accept the fact that (1) the "Land Jurisdiction" exists and is owed by the Church's Global Estate Trust, and (2) that men and women may freely operate in such jurisdiction that we are owed as a beneficial interest.

All these de jure and de facto governments and their agencies and department, as well as all other corporate, artificial and fictitious entities (including their representatives) are a creature of the State, that is to say, of the Church, the Church's Global Estate Trust, and they are presumed to be created/incorporated for the benefit of the public at large, noting that men and women receive nothing from the State beyond the protection of their life and property. When such entities, de jure and de facto violate this obligation, they are entitled to and should be placed out of business, with any man and/or woman operating and directing such agencies being held legally and criminally personally accountable for their fraudulent involvement in illegal activities perpetrated against all the inhabitants on planet Earth, noting that there is no statute of limitations on fraud, in particular commercial and criminal fraud as described herein.

The above organizations, governments and corporations have further been involved in fraud, personage, plundering, barratry, piracy over sea and inland, kidnapping, impressment, imprisonment, assassination, hypothecation, having change the definition of the term "person" in their laws, codes and regulations, from that referring to a man and or woman, to referring to artificial, fictitious entities, in order to make men and women believe that their de facto administrative decisions, legislation and laws apply to men and women, when in fact they do not, as noted in the paragraph above.

Due to their failure to abide by their charters, these corporations are to be orderly but swiftly disbanded and liquidated, with no personal immunity to any of its representatives responsible for the denounced continental and global fraud and crime.

THE WORLD AND THE DARK POWERS THAT ENSLAVE IT

In the Bible, Judges 8:23, it notes that Gideon, a judge of the Israelites, when asked by the men of Israel to rule over them, he said, ***“And Gideon said unto them, I will not rule over you, neither shall my sonne rule over you: the Lord shall rule over you.”*** This is obviously based on the fundamental principle of theocracy, that GOD IS KING, and no man or woman, or any authority deriving from such man and woman can or is intended to supersede the divine authority of God.

All administrative agencies, including all trial, and appellate (superior/supreme) courts, including those of the Church, have little or no discretion in most matters, thus they are called “ministerial” agencies, as “administering” the state (estate), which means, when taken to its ultimate conclusion, Babylonian King Hammurabi’s **original**, the world’s first written and one and only one-world estate, one-world government, **one-world state (estate) of SLAVES**, noting that the “Law looks to the past.” All the empires that have followed Hammurabi and were later established, are at best mere and illegitimate fragments of Hammurabi’s original one-world state/estate, which is doing its best to turn (coalesce) into its original one-world form, yet **NO LEGISLATION FROM ANY SOURCE WHATSOEVER CAN CONTEMPLATE THE NATURAL BORN MAN AND WOMAN, BUT CONTEMPLATES AND APPLIES ONLY TO THE STATE, ITS PROPERTY, AND THE GOVERNMENTAL OFFICES/OFFICERS INTO WHOSE HANDS THEY ARE PLACED FOR ADMINISTRATION, MAINTENANCE AND SAFE KEEPING.**

I/We reject, ab initio, the belief and/or theory that the Church or Hammurabi’s Code and its supposed authority applies to me, my person or to any and all men and women. God did not create slaves, God created spiritual beings that live and reside within men and women’s bodies (see 1 Corinthians 3:16-17). It was men like Hammurabi, without any real forensic, empirical proof of such authority, but only through their own personal written claims, mere documented imaginary legally binding fictions and brute force, who took it upon themselves to enslave others and men and women as a whole, making perverted declarations that in one form or the other, God wished men and women to be enslaved. Pope Boniface VIII, as did Hammurabi, took it upon themselves to claim that the Church/Hammurabi’s government also had authority over the world and all its inhabitants and resources.

All these enterprises and actions of some men to take advantage of and plunder others of their wealth and natural rights, to their personal benefit, have resulted in this “State of Enslavement” that ever since all men and women have lived under, that has been perpetuated in one form or the other for centuries, the Estate’s rule passing from one hand/government to the other through military and economic conquest throughout history, made supposedly binding on all men and women through all subsequent writings/agreements/charters dating back to Hammurabi.

By its actions as well as inactions, the Church’s Global Estate Trust is being mismanaged, abused and plundered by the above entities, not only placing **the Church at risk of lawsuits**, but more importantly, affecting the lives and well-being of all men and women on our planet, under guise of “freedom” and “democratic” adventures of the so called United States of America’s de facto government, as described above. Due to this, I request and demand that the **actions noted below be taken immediately by the Church** through the Pope and his agents and representatives, to advise all involved world governments, de jure and de facto, to ensure that the following things happen immediately, to help stop this ongoing abuse on me, my family and on all other men and women’s lives, our freedom’s and our property around the world.

If the Pope and Church fail to take action as noted above, then the Church is not representing God as noted in the Unam Sanctam and therefore loses all spiritual, land and sea jurisdiction and authority over all global governments, institutions and all men and women for breach of contract (spiritual and as declared by the Church in the Unam Sanctam), by misrepresentation and by fraud.

If such is the case then all world governments are therefore relieved from all obligations towards the Catholic Church, including payments of any monetary and financial obligations owed in any form, including the payment, benediction, and consecration of the tithes (as noted in the Unam Sanctam), contributions for each man and woman and/or citizen of any country, etc.

Further, all supposed contracts and financial obligations between the Church and any government and individuals, such as charters, corporate documents, Papa Bulls, in the form of taxation, interest, dividends, annuities, permits and licenses are null and void, whether such obligations are present, future or past as in the case of past due financial obligations towards the Church.

REMEDY AND RELIEF REQUESTED – PROOFS REQUIRED

It is impossible to list here all the abuses committed against men and women by all the governments and corporations referenced above, but they include illegal taxation, control of currency/legal (sic) tender and banking, control and concealment of alternative forms of energy denied to all men and women, attacks on all natural cancer and other disease cure providers outside of the orthodox medical establishments and big pharma's often harmful and even deadly therapies, toxic and mandatory vaccines, the promotion and authorization of GMO foods without proper testing, war after war throughout the world, forced sterilization, contamination of the environment, illegal imprisonment (such as that related to the so called "war on drugs"), rape, torture, assassination, genocide, enslavement of the masses, etc.

While I/we ask the Church to put a stop to all of the above things and correct all these ills against men and women as soon as possible by disbanding the above organizations and prosecuting the perpetrators so they cannot do it again, of most importance and for now I/we particularly request the following:

1. Stop all commercial, civil, military and governmental geoengineering/solar radiation management activities, known worldwide as chemtrails, the purposeful spraying of toxic substances into the air at different levels like the troposphere and stratosphere, in particular, large scale geoengineering activities of any kind, the spraying of any substance in any region of the world's atmosphere; as well as all activities related and similar to the High Frequency Active Auroral Research Program, HAARP, and any radio frequency stations and systems used for weather manipulation around the globe, until the following occurs:
 - a. The de jure and/or de facto government of the United States confirms through mass media that such activities have been taking place, and
 - b. Explains in detail how long it has been occurring and to what degree,
 - c. Advises what substances have been used,
 - d. Advice for what various purpose these substances where sprayed,
 - e. Advise under what authority where these activities carried out,
 - f. Identify by name and title all persons responsible for authorizing such activities,

- g. Identify by name, company/government agency and position all individuals involved in the planning and carrying out of such activities,
- h. Identify by name any and all individuals and organization of any kind that benefitted from such illegal/concealed toxic spraying, and
- i. Identify by real name and title, including nicknames and invented names, of all persons being used as disinformation agents claiming that such massive spraying of toxic chemicals, where nothing more than mere contrails and that no such chemtrails programs have ever existed, such as Mick West from www.Metabunk.org.

FUTURE LARGE SCALE GEOENGINEERING ACTIVITIES, FOR WHATEVER REASON, INVOLVING THE MASS SPRAYING OF SUBSTANCES INTO THE ATMOSPHERE ARE TO BE, FROM NOW AND FOREVER, PROHIBITED AROUND THE WORLD, UNTIL AN OPEN DEBATE CAN DETERMINE, NOT ONLY IF SUCH GEOENGINEERING IS SAFETY FOR MEN AND WOMEN AND THE ENVIRONMENT, BUT ALSO TO DETERMINE IF IN FACT THERE IS A CLIMATE CHANGE EMERGENCY THAT JUSTIFIES SUCH DANGEROUS ACTIONS.

PROOF: Halt immediately all geoengineering activities and have President Donald J. Trump or his successor hold a national news conference to admit such geoengineering activities have been taking place and have been halted, and advising when all of the things requested above will take place and become available, such things to be made available no more than 30 days from the publication of this public correspondence. Have the disinformation agent known as Mick West of www.metabunk.org, appear on all three major US television stations, ABC/CBS/NBC, advising about the deception he was involved in, why and under whose authority and to confess who else was involved in this illegal and toxic enterprise, such as David Keith and Ken Caldeira. Such appearances are to happen within 10 days of the U.S. President informing the public about the geoengineering activities.

2. Immediate prohibition of any and all mandatory vaccines on any baby, child, teenager or adult, for any purpose, such as (1) administration of vaccines in order to get medical attention, including birth; (2) attending school, (3) for purposes of employment; and (4) in order to travel, and or (5) to immigrate into the United States, if the administration of the vaccine is against that person's personal, medical and/or religious beliefs. This includes the right to not vaccinate any person under the care and control of such person which is against vaccines.

PROOF: U. S. President Donald J. Trump is to issue an executive order noting that the federal government (sic) will not demand vaccination of any person in order to provide any services, such as school, veteran and medical services for any purpose, if against that person's personal, medical and/or religious beliefs. This includes a ban on the federal government from not providing any sort of funding for any state, county or local agency due to recipient's vaccine use inclination.

President Trump will order the heads of the Department of Justice, Department of Health and Human Services, and the Department of Education to immediately act upon the Civil Rights and Criminal Complaint filed with each department by Mr. Ricardo Beas and others that joined him in his Class Action Complaint on or around July 7, 2017, by taking action as is noted in the "Remedy and Relief Requested" section of such complaint. Such complaint is titled: "CLASS ACTION COMPLAINT: VIOLATION OF CIVIL RIGHTS AND CRIMINAL CONSPIRACY BY CRIMINAL PARTICIPANTS -- FIRST AMENDMENT DEMAND FOR CIVIL AND CRIMINAL PROSECUTION AND WITHHOLDING OF FEDERAL FINANCIAL ASSISTANCE – RESTITUTION FOR HARM AND INJURY," which have been assigned the following identification number by the involved agencies: by DOJ I.D. # DJ 144-11-0; by HHS Transaction # 17-277069; by DOEd Case # 09-17-1609.

The Congress of the United States (sic) is to issue legislation to the same effect. California Governor Gerry, as well as the California Congress, are to rescind recent legislation, such as SB 277 and SB 792, which mandates vaccines in order to attend school and work in certain industries. All California schools are to immediately stop requiring proof of any vaccination in order to attend school. All employers will immediately stop requiring vaccination from their employees in order to obtain or maintain employment. If at all, it should be offered as an option, not a requirement.

3. Pope Francis is to issue a Motu Proprio Apostolic letter prohibiting all governments, de facto or de jure, corporate entities, fictitious entities in general, associations, institutions, news media outlets, persons, individuals or men or women from engaging in activities related to toxic geoengineering and mandatory vaccination programs as described in 1 and 2 above, whether promoting and/or actually participating in such activities.

Similar to Pope Francis' Motu Proprio Apostolic letter of July 11, 2013, such new Motu Proprio as mentioned in 3 above should include language acknowledging the competent Judicial authorities of Vatican City State, exercising penal jurisdiction over crimes committed against all men and women, God's Children, and the security, the fundamental interests and the patrimony of the Holy See. This authority should extend to public officials and personnel of the various organs of the Roman Curia and of the Institutions, corporations and trusts connected with it, as well as over all the countries and governments in the world, de facto or de jure, where the Church has or claims jurisdiction and authority to so act.

CONCLUSION AND FINAL THOUGHTS

God is not going to save our souls; we are all individually going to save our own soul from the karma of having done any harm to any single person, community or the world at large. The Church is being given an opportunity to show that indeed, regardless of past deeds, it will now ensure that all of the abuse described above is controlled, disbanded and ended, for the sake of a life of prosperity for all men and women. **FAILURE TO DO SO WILL RESULT IN A VIOLATION OF THE CHURCH AND POPE OF THE UNAM SANCTUM TRUST/CHARTER AND THEREFORE RESULTS IN FRAUD, STRIPPING THE CATHOLIC CHURCH AND THE POPE FROM ALL SPIRITUAL AND TERRESTRIAL AUTHORITY, AND OF ALL SPIRITUAL, TERRISTRIAL AND LEGAL IMMUNITY FROM CIVIL ACTION AND CRIMINAL PROSECUTION, SO SAITH THE LORD.** Isaiah 45:1-2.

THIS IS YOUR SECOND NOTICE OF LIABILITY¹⁵ – I DEMAND THAT YOU CEASE AND DISIST FROM ALL DETRIMENTAL NEGATIVE AND EVIL ACTIONS AGAINST ME AND ALL MEN AND WOMEN, WHICH AFFECT OUR UNILEANABLE GOD-GIVEN RIGHT TO LIFE, GOOD HEALTH, TO PROCREATE, TO FREEDOM AND TO THE PURSUIT OF HAPPINESS.

It all begins with the **IMMEDIATE** imposition of the Church’s authority and obligation to follow the Law and rule of God, with the offender’s admission of sins. It follows that repentance must correct the sins of the past to the degree possible and must punish those responsible for such transgressions against mankind, with such sinners indemnifying all harmed men, women and children.¹⁶ Such malicious persons are to be made an example of.

The World is vast, and all its resources can be exploited intelligently and in an environmentally correct and safe manner – it all starts with free and unlimited ENERGY, once the corruption noted above is stopped and the air we breathe is restored.

It is now up to the Church to show its intent, for the world to judge, to admire or to abhor, with our prayers to God that the Church and all its institutions will take swift action as is demanded herein and proven necessary in this writing.

BE FURTHER ADVISED THAT THIS NOTICE OF LIABILITY HAS NOW BEEN PUBLISHED WORLD-WIDE AND OTHER PEOPLE WILL BE REQUESTING IN WRITING THROUGH THEIR LOCAL CATHOLIC PARISHES THAT POPE FRANCIS, HIS SUCCESSOR AND THE CHURCH TAKE IMMEDIATE ACTION AS NOTED HEREIN.
