Dear Medical Practitioners, Sirs and Madams,

Throughout history humanity has gone through periods where knowledge has been held in the hands of a few, knowledge is manipulated to their advantage and as a consequence they have maintained the world in darkness and have prosecuted those that went against status quo truths. The most extreme example was the Catholic Church trying to deny that the Earth was round and that it orbited the sun.

Monopoly of knowledge is something that impacts every individual. When it comes to Monopoly of Medical Knowledge, it becomes the power over life and death. That is the reason for this letter to you.

We thank and honor “medical marihuana” advocate physicians and doctors that have broken with the medical monopoly (Big Pharma, large medical institutions, FDA, CDC, DEA, many general medical practitioners, etc. ad nauseam), that understand that (1) nature provides us with natural remedies that have minimal or no side effects that can cure most all diseases, and (2) that the pharmaceutical products now being sold for most diseases, as well as the therapies and medical interventions that have grown around them, are so filled with toxic chemicals and related side effects that hundreds of thousands of children and adults are being killed and injured by these products every year, many suffering neurological disorders for life as a result; even medical overdoses are common.

These same pharmaceutical giants and their foundations are also behind the orthodox medical education system, controlling curriculum, eliminating the focus on nutrition and natural remedies and substituting them for man-made expensive toxic pharmaceutical products, turning hospitals, doctors and medical specialists into federally-sanctioned drug dealers, who simply write the prescription and help administer big pharma’s harmful, anti-natural products, in particular all those that can be patented. Any natural substances or treatment that may cure disease, but are not patentable or are of low profit margin are discarded, discredited, ridiculed, and with the help of corrupt authorities, their promoters and sellers prosecuted, jailed and even murdered.¹ See also the attack of the AMA against chiropractors.

By issuing Medical Marihuana Licenses, you are helping people take an alternative natural, none toxic way to address many diseases that have been proven can be cured, helped and alleviated by the use of marihuana and its derivatives, even for things as serious as cancer.

Through this letter/notice, I/we are now asking you to do the same for parents of children facing mandatory vaccination in order to attend school, as well as workers of certain educational and other businesses and institutions, including day care, nursery, adult caregivers, school personnel, etc., to issue **INDIVIDUAL VACCINE EXEMPTION LETTERS** for people to use to deter the government from forcing children or adults to get vaccinated in order to go to school or work at any establishment. Here are the facts about vaccines that prove (1) the case against vaccine safety, and which is a perfect foundation for any reasonable, objective medical practitioner to come to the conclusion that vaccines don't work and are even dangerous, (2) that the approach of using vaccines instead of natural homeopathic treatments is misplaced and unnatural, (3) that any vaccine on any patient is harmful, in most cases unnoticeably (yet cumulative), but in many cases resulting in autistic symptoms and neurological disorders and in some cases even in death:

You are also encouraged and requested to do your own independent research on the subject. One thing you will find is that **"there is no settled science when it comes to vaccine safety."** Simply keep this in mind:

- a. There are no long term vaccine studies done on any children or adults.
- b. As noted in the documentaries above, the studies are fraudulently manipulated to minimize the risk and dangers of vaccines.
- c. When disease outbreaks happen, like whooping cough, the majority of the victims are children that were vaccinated and current on their shots. See Exhibits 1, 2 and 3 in #4 above.
- d. No studies have been conducted to compare vaccinated vs. unvaccinated children or adults to determine if indeed vaccination makes a difference.
- e. There are no short or long term studies of possible vaccines adverse effects when taken in groups of vaccines at the same time, whether when they combine several vaccines in one like MMR and Tdap, to when these are combined with others and given the same day.
- f. All vaccine inserts noted in 5 above specifically state that they have not been tested to see if any of them can cause cancer.

- h. The federal Vaccine Court: Office of Special Masters of the [U.S. Court of Federal Claims](#) has paid billions in claims to families of people injured and killed by vaccines, and that despite the fact that the majority of the cases are wrongfully decided against and denied, an estimated +80%.
- i. The U.S. Constitution confirms people's right not to be vaccinated based on their religious beliefs.
- j. The California Constitution reiterates the natural and common law right to be safe where it declares in Article 1, section 1:

ALL PEOPLE ARE BY NATURE FREE AND INDEPENDENT AND HAVE INALIENABLE RIGHTS. AMONG THESE ARE ENJOYING AND DEFENDING LIFE AND LIBERTY, ACQUIRING, POSSESSING, AND PROTECTING PROPERTY, AND PURSUING AND OBTAINING SAFETY, HAPPINESS, AND PRIVACY.

- k. Internationally, the Nuremberg Code and Universal Declaration on Bioethics and Human Rights UNESCO prohibits forced medication. Article 6, section 1 states:

Any preventive, diagnostic and therapeutic medical intervention is only to be carried out with the prior, free and informed consent of the person concerned, based on adequate information. The consent should, where appropriate, be express and may be withdrawn by the person concerned at any time and for any reason without disadvantage or prejudice.

- l. There are many studies that conclusively prove that vaccines cause autism and other serious illnesses (some studies are listed at end of this letter).

The evidence provided above, coupled with your own exhaustive inquiries (those that are implied and are demanded from physicians by their Hippocratic oath) will prove to you unequivocally that vaccines can potentially damage any person at any time, and simply because of that possibility, it is justified for any medical practitioner, such as you, having reviewed all of the above facts that there is as much a risk of injury to any person taking vaccines, as it is for any person who has a personal or family medical history of adverse reactions to any or all vaccines.

ONE IMPORTANT POINT: Presently there is no orthodox medical cure for autism and similar serious mental disorders, such as Guillain-Barré syndrome and encephalitis. Persons with these diseases are simply given psychotropic sedatives to keep them under control. All vaccine inserts state (even the CDC flyers) that no one should get the vaccines if they have had such a reaction after taking it. COMBINED, THIS MEANS THE HARM, IF IT HAPPENS, IS IRREVERSIBLE – **THERE IS NO EXCUSE TO WAIT TO SEE IF IT HAPPENS ON THE FIRST OR SECOND SHOT! IT SHOULD BE AVOID, PERIOD.**

Here is the link to the form approved by the American Academy of Pediatrics, as well as by the California Academy of Family Physicians, that can be used by a physician to issue the vaccine exemption for any child up to school age, for any reason the physician considers valid and justified:

Exactly what reason(s) and to what extent physicians have to write and justify why they issued the medical vaccine exemption is not clear nor defined by the text of SB 277 and other related California assembly and senate bills. Personally, anti-vaccine activist such as myself believe that the doctor can simply claim that there is no proof provided by the vaccine manufacturers to ensure that harm, to whatever extent, will not be suffered by the child or person being vaccinated, as others have been.

One doctor, San Francisco physician Dr. Ken Stoller, a long advocate against vaccines, fills out vaccine medical exemptions using a child or person's DNA history to reach the same conclusion to justify issuing the vaccine exemption. One very interesting comment Dr. Stoller makes is that if vaccines are safe, we should get our doctors and hospitals to sign a waiver of liability so that if someone gets injured by the vaccine, they can come back against the doctors, hospitals and manufacturers. IMPORTANT: Another doctor using a similar approach, Dr. Kelly Sutton, MD, has a video that explains their procedures for making determinations related to certain person's medical reasons why not to vaccinate and even sells a package of data that parents can offer their physician so the physician can make a better informed decision on an individual person's risk of vaccination.

I/we are all waiting and praying for physicians and doctors such as yourself to view all the evidence and to join us not only in opposing vaccines (and obviously to stop promoting them for anyone), but also in writing the vaccine medical exemptions for any individual whose medical, personal, religious, logical and/or reasonable beliefs are against vaccines for them and/or their children.

Because the dangers of all vaccines have not been thoroughly studied and there is existing evidence that any vaccine can harm anyone at any time, whether a childhood vaccine or a flu vaccine for an elder person, such vaccine exemptions **MUST BE MADE TO COVER ALL EXISTING VACCINES FOR LIFE**. Else this would be a contradiction of the physician's position that vaccines are unsafe, and could also be interpreted to be a fraudulent way to get innocent victims to be unnecessarily renewing the vaccine exemptions every so often at an additional expense to them.

Once you contact me and advise that you are willing to consider all the information provided herein and have decided to see patients with the purpose of evaluating them and issuing them such medical vaccine exemptions, I will proceed to contact your office at the appropriate time to make an appointment for me and/or all necessary family members.

Additionally, I will advise all my family and friends about you and your practice and your willingness to help us fight this horrible injustice with the potential of autistic effects and in some cases death. If fine with you, I will also actively promote your services through social media and with anti-vaccine organizations and institutions so they know they can count on you to honestly approach the issue of vaccine safety and also issue medical vaccine exemption where appropriate, at a reasonable doctor's visit or other rate. I would also recommend you advertise such medical services, "vaccine medical exemption evaluations" or whichever name sounds appropriate, so others will know about your services.
